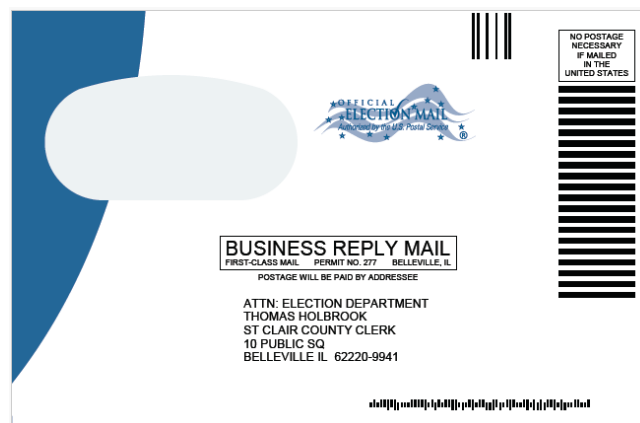


Outer Envelope

Instruction Sheet with Sticker

Instructions to Vote by Mail Voters

(Please follow all instructions carefully)

With this instruction sheet you should have received the following:

1. An Official Ballot (listing candidates/offices and propositions to be voted).
2. Return Envelope (voted ballot to be sealed inside) - On Reverse Side of Return Envelope is the Certification/Authorization section.

Read the ballot carefully noting the offices, the candidates' names, the number to be elected and any propositions; including any Constitutional Amendments, Judicial Retention questions on the ballot.

Mark the ballot in this manner:

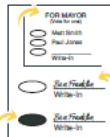
1. Select the candidates of your choice (do not vote for more than you are entitled).
2. Opposite the name of each candidate is an oval.
3. Using a black ball point pen, completely darken the oval corresponding to the candidates of your choice and the propositions (if any) of your choice.

How to cast a write-in vote:

1. On your ballot, find the office for which the candidate is running.
2. Print the candidate's name on the Write-In line for that office.
3. Fill in the oval next to the candidate's name.

After you finish voting:

1. Insert ballot into the return envelope. Complete and sign Certification/Authorization on the back of the return envelope. Mail back to the County Clerk.
2. The ballot may be delivered in person to the Election Authority by any person who is authorized by the voter. If the voter authorized a person to deliver the ballot to the Election Authority, the voter and the person authorized to deliver the ballot shall complete the authorization printed on the return envelope.
3. Return your Ballot by mail or drop it off at the County Clerk's office at 10 Public Square, 2nd Floor, Belleville, IL 62220. A Ballot Drop Box is also located in front of the County Courthouse.

Mailed ballots will not be counted if:

1. They are postmarked later than election day, or if received in the St Clair County Clerk's Office more than 14 days after the election.
2. If there is no signature and date on the Ballot Certification envelope.

If you spoil your ballot in any manner:

1. First call the St. Clair County Clerk's office at 618-825-2379 to confirm the ballot is indeed spoiled.
2. You may also take the spoiled ballot to your polling place on Election Day and surrender it in order to cast a new ballot.

To follow the status of your ballot, retain your stub and visit StClairBallotTrack.com and enter your Ballot Track ID listed on the stub. Or, use a smartphone and scan the QR code on the ballot stub.
