November 2024

Environmental Review Pending. Surveys underway. Design underway \$55,523.25 was disbursed during November 2024.

December 2024

Gay & McCasland engineer working on design. Environmental review is underway for Gay & McCasland. **\$0** was disbursed during December 2024.
