- You did not sign a valid Voluntary Acknowledgment of Paternity (VAP) for the child(ren);
- You are not currently married to the child(ren)’s mother, and, if you were ever married to her, you got divorced at least 300 days before the birth of the child(ren).
- The child(ren) and the mother have certain connections to Illinois. (See sections 4 and 9 of this form for more information.)
- The child(ren) have not been adopted (including adoption by the mother’s husband).

CAUTION: There are deadlines and other special rules that may apply to your case if:

- There is already a court order or court case about the child(ren) (including a divorce order that describes the child(ren) as “child(ren) of the marriage;”)
- Someone signed a valid Voluntary Acknowledgment of Paternity for the child(ren); or
- The mother was married to someone else at the time of the birth(s) of the child(ren), or married someone else after the birth(s) of the child(ren) and that person is listed as the father on the birth certificate.

If you think any of these apply to your case, you should talk to a lawyer about your options.

**FATHER’S PETITION TO ESTABLISH PARENTAGE AND
